CULAC is the federal political action committee of the Credit Union National Association. Individual contributions to CULAC are used to support candidates who are running for federal office.

Contributions to CULAC are not tax deductible. Contributions are strictly voluntary and will be used for political purposes. You have the right to refuse to contribute without any reprisal. Making a contribution to CULAC does not increase your chances of winning.

Eligibility: This sweepstakes is open to residents of the continental United States, Alaska, and Hawaii who are eligible to contribute to CULAC. You must be 18 years of age or older as of the date of entry in order to enter. Offer void where prohibited. Individuals located in Florida, Georgia, Texas, and Minnesota are not eligible to participate in the contest because of state law. Contest is void in Florida, Georgia, Texas, and Minnesota.

Duration of Sweepstakes: The sweepstakes begins at 5:00 P.M. EDT on 03/10/2019 and ends at 11:00 A.M. EDT on 03/14/2019.

Three Methods of Entry: No purchase or contribution is required to participate in the sweepstakes. (1) Individuals who make a contribution to CULAC between 03/10/2019 and 03/14/19 by following the instructions located at Political Affairs booth at the Government Affairs Conference are automatically entered in the drawing. (2) Existing CULAC contributors may enter the drawing by sending an email titled “ENTRY TO SWEEPSTAKES” with the participant’s name, telephone number, and e-mail address to abyun@cuna.coop until 11:00 A.M. EDT on 03/14/2019, or by personally hand-delivering this same information in writing to Andrew Byun during the same time period. (3) Individuals who are not CULAC contributors and who do not wish to contribute to CULAC at this time may enter the drawing through the same process outlined above for existing CULAC contributors.

All sweepstakes entries become the property of Sponsor. Entries will not be returned. The grand prize winner will be sent a W-9 form for the grand prize value.
